In an important Chapter on the government's power to act in a crisis, Professor Sievert proceeds from the important civil war case of *Ex Parte Milligan* outlining martial law to a review of the last decade's critical cases on habeas corpus, military commissions and military assistance. In the final section the casebook examines the War Power with historical cases on Executive versus Congressional authority, efforts to stop the Vietnam and Iraq wars and attacks on Yugoslavia and Libya, a Gulf War Chronology and summary of the effects of the War Powers Act and a review of the Authorizations for Use of Military Force 2001, 2002 as well as the government's recent legal justifications for drone attacks.
